CONTRACT AGREEMENT

THIS AGREEMENT made this ___ day of _____ 2023 between **DEPARTMENT OF AGRICULTURE – BUREAU OF FISHERIES AND AQUATIC RESOURCES (DA – BFAR)** of Fisheries Building Complex, Bureau of Plant Industry Compound, Visayas Avenue, Diliman, Quezon City, Philippines 1101 (hereinafter called “the Entity”) and **CARESYSTEM TECHNOLOGY SOLUTION CO., INC** of Door 1,2,3,4 LS Bros., BLDG., KM 5 Buhangin Road, Brgy. Buhangin Davao City, Davao Del Sur, Philippines, (hereinafter called “the Contractor”).

WHEREAS, the Entity is desirous that the Contractor execute “**SUPPLY, DELIVERY, AND INSTALLATION OF AIRCONDITIONING UNIT FOR FISHCORE AT 2ND FLOOR OF NFA BUILDING**” with **BID REFERENCE NO. 2023 – 66** (hereinafter called “the Works”) and the Entity has accepted the Bid for **ONE MILLION FIVE HUNDRED FORTY THOUSAND PESOS ONLY (Php 1,540,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

a. Philippine Bidding Documents (PBDs);

- i. Drawings/Plans;
- ii. Specifications;
- iii. Bill of Quantities;
- iv. General and Special Conditions of Contract;
- v. Supplemental or Bid Bulletins, if any;

b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

c. Performance Security;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **ONE MILLION FIVE HUNDRED FORTY THOUSAND PESOS ONLY (Php 1,540,000.00)** or such other sums as may be ascertained, **CARESYSTEM TECHNOLOGY SOLUTION CO., INC** agrees to **BID REFERENCE NO. 2023 - 66** entitled **"SUPPLY, DELIVERY, AND INSTALLATION OF AIRCONDITIONING UNIT FOR FISHCORE AT 2ND FLOOR OF NFA BUILDING"** in accordance with his/her/its Bid.

4. The **DA - BFAR** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
