INVITATION TO BID FOR BID REFERENCE NO. 2024 – 01 (RE-BIDDING)

"PROCUREMENT OF FLEET CARD PROGRAM FOR FUEL (DIESEL/GASOLINE), OIL, LUBRICANTS, AND CHANGE OIL SERVICES FOR BFAR VEHICLES AMONG OTHERS FROM APRIL TO DECEMBER 2024"

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA – BFAR), through the General Appropriations Act (GAA) for FY 2024 intends to apply the total sum of **Twenty-Three Million Two Hundred Eleven Thousand Two Hundred Seventy pesos only (PhP 23,211,270.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the "PROCUREMENT OF FLEET CARD PROGRAM FOR FUEL (DIESEL/GASOLINE), OIL, LUBRICANTS, AND CHANGE OIL SERVICES FOR BFAR VEHICLES AMONG OTHERS FROM APRIL TO DECEMBER 2024" with Bid Reference No. 2024–01 (Re-Bidding). - 2. The DA BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in Section VI Schedule of Requirements. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- **3.** Bidding will be conducted through open competitive bidding procedures using a non-discretionary *"pass/fail"* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- **4.** Prospective Bidders may obtain further information from DA BFAR BAC Secretariat and inspect the Bidding Documents at the address given below during office hours from **8:00 AM** to **5:00 PM, Mondays to Fridays**.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders at 2nd Floor, BAC Office, Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Diliman, Quezon City, and/or through electronic means and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or through electronic means.
- 6. The DA BFAR, will hold a Pre-Bid Conference through video conferencing or webcasting via the **"Zoom"** application which shall be open to prospective bidders who have successfully completed registration one (1) calendar day prior to the Prebid Conference using Google Form
