"GENERAL OVERHAULING OF PORT MAIN ENGINE AND OTHER ADDITIONAL REPAIRS OF DA-BFAR MCS 3009 PATROL VESSEL"

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DABFAR), through the General Appropriations Act for 2024 intends to apply the sums of FOURTEEN MILLION NINE HUNDRED SIXTY-EIGHT THOUSAND TWO HUNDRED FIFTY-TWO AND 40/100 PESOS ONLY (Php 14,968,252.40) being the ABC to payments under the contract for Bid Reference No. 2024-04 entitled "GENERAL OVERHAULING OF PORT MAIN ENGINE AND OTHER ADDITIONAL REPAIRS OF DA-BFAR MCS 3009 PATROL VESSEL".

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 1. The DA BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI Schedule of Requirements. Bidders should have completed, within **FIVE (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

- **a.** Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 3. Prospective Bidders may obtain further information from DA BFAR BAC Secretariat and inspect of the Bidding Documents at the address given below during office hours from 8:00 AM to 5:00 PM, Monday to Friday or download the at www.bfar.da.gov.ph.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders at the 2nd Floor, BAC Office, Fisheries Building Complex, BPI Compound, Brgy. Vasra, Visayas Ave., Quezon City and/or through electronic means and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount stated above. The Procuring Entity shall allow the bidder to present its proof of payment for the fees by in person, or through electronic means.

The DA BFAR, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
