"SUPPLY AND DELIVERY OF MARINE GROWTH PREVENTION SYSTEM FOR MAIN SEACHEST STRAINER AND MAINTENANCE OF SPARE MATERIALS AND PARTS FOR ENGINE AND SKIFF BOAT OF M/V DABEAR"

- 1. The Department of Agriculture Bureau of Fisheries and Aquatic Resources (DA BFAR), through the General Appropriations Act (GAA) for FY 2024 intends to apply the total sum of THREE MILLION EIGHT HUNDRED EIGHTY THOUSAND PESOS ONLY (PhP 3,880,000.00) being the Approved Budget for the Contract (ABC) to payment under the contract for the Procurement of "SUPPLY AND DELIVERY OF MARINE GROWTH PREVENTION SYSTEM FOR MAIN SEACHEST STRAINER AND MAINTENANCE OF SPARE MATERIALS AND PARTS FOR ENGINE AND SKIFF BOAT OF M/V DA-BFAR" with Bid Reference No. 2024–14. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The DA BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI Schedule of Requirements. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - **a.** Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from **DA BFAR BAC Secretariat** and inspect of the Bidding Documents at the address given below during office hours from **8:00 AM** to **5:00 PM**, **Monday** to **Friday**.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders starting March 20, 2024, from 8:00 AM to 5:00 PM, Mondays to Fridays, except holidays from the given address and website/s below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the stated below. The Procuring Entity shall allow the

bidder to present its proof of payment for the fees by in person, or through electronic means.

The DA - BFAR, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
