## SUPPLY, DELIVERY AND INSTALLATION OF DUCTING, ERV UNITS AND AIRCONDITIONING UNITS FOR BFAR LABORATORY BUILDING

1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DABFAR), through the General Appropriations Act for 2024 intends to apply the sum of NINETY-NINE MILLION NINE HUNDRED EIGHTY-FOUR THOUSAND TWO HUNDRED SEVENTY-FOUR AND 56/100 ONLY (Php 99,984,274.56) being the Approved Budget for the Contract (ABC) to payment under the contract for Bid Reference No. 2024-17 entitled "SUPPLY, DELIVERY AND INSTALLATION OF DUCTING, ERV UNITS AND AIRCONDITIONING UNITS FOR BFAR LABORATORY BUILDING".

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- **2.** The DA BFAR now invites bids for the above Procurement Project. Completion of the Works is required within *SIXTY (60) calendar days* upon receipt of the Notice to Proceed. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- **3.** Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
