1. The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA – BFAR), through the General Appropriations Act (GAA) for FY 2024 intends to apply the total sum of **SEVEN MILLION TWO HUNDRED SEVENTY-SIX THOUSAND EIGHT HUNDRED NINETY-SIX PESOS ONLY (PhP 7,276,896.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the Procurement of **“SUPPLY, DELIVERY, AND INSTALLATION OF FOUR (4) UNITS 20M DIAMETER SINGLE PIPE HDPE OFFSHORE SEAWEED CAGE AT DENRICA, GARTCHITORENA, CAMARINES SUR”** with **Bid Reference No. 2024-18**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DA – BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI - Schedule of Requirements. Bidders should have completed, within **five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.


