**RESOLUTION RECOMMENDING THE AWARD OF THE CONTRACT UNDER BID REFERENCE NO. 2024-04 GENERAL OVERHAULING OF PORT MAIN ENGINE AND OTHER ADDITIONAL REPAIRS OF DA-BFAR MCS 3009 PATROL VESSEL TO JOSEFA SLIPWAYS INC. AS THE BIDDER WHO OFFERED THE SINGLE CALCULATED AND RESPONSIVE BID**

**WHEREAS,** Purchase Request No. 24-01-39 pertains to the “**GENERAL OVERHAULING OF PORT MAIN ENGINE AND OTHER ADDITIONAL REPAIRS OF DA-BFAR MCS 3009 PATROL VESSEL**” with an Approved Budget for the Contract amounting to **Php 14,968,252.40**;

**WHEREAS,** the BFAR Bids and Awards Committee (BFAR-BAC) advertised the Invitation to Bid for the above-mentioned procurement project consisting of one (1) lot through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) with reference number 10537728, the Bureau’s website ([www.bfar.da.gov.ph](http://www.bfar.da.gov.ph)) and in conspicuous places within the Bureau’s premises for seven (7) days;

**WHEREAS,** the following bidders, viewed the invitation posted at the PhilGEPS website ([www.philgeps.gov.ph](http://www.philgeps.gov.ph)), namely:

- Josefa Slipways, Inc.
- Propmech Corporation

**WHEREAS,** on February 05, 2023 (Monday) at 09:00 am, the Pre-Procurement Conference was conducted by the Bids and Awards Committee (BAC) via Zoom;

**WHEREAS,** on February 16, 2024 (Friday) at 11:00 am, the Pre-bid Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and was attended only attended by Josefa Slipways Inc.;

**WHEREAS,** on January 16, 2024 (Tuesday) at 10:00 am, the Bid Opening Conference was conducted by the Bids and Awards Committee (BAC) via Zoom and only Josefa Slipways Inc. submitted their bid;

**WHEREAS,** during the opening of the Eligibility and Technical Envelopes the abovementioned bidder “PASSED” the evaluation and was declared eligible for the opening of the financial envelopes;

**WHEREAS,** during the opening of the Financial Documents of the above-mentioned bidder, “As Read” is as follows:

**WHEREAS,** after reading and determining the amount of bids as proposed by the qualified bidder/supplier, the BAC declared **JOSEFA SLIPWAYS INC.** as the bidder who offered the single bid as read for the said procurement project and will be

**WHEREAS,** in the detailed bid evaluation report submitted by the Technical Working Group (TWG), it was proposed that **JOSEFA SLIPWAYS INC.** be declared as the **Single Calculated and Responsive Bidder** and therefore recommended to proceed in the conduct of Post Qualification procedure;

**WHEREAS,** the Technical Working Group (TWG) recommended in the post-qualification report that the award for procurement project be awarded to **JOSEFA SLIPWAYS INC.** for being the **Single Calculated Responsive Bidder**;

**NOW THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED,** that the procurement of the project with Bid Reference No. 2024-04 entitled **GENERAL OVERHAULING OF PORT MAIN ENGINE AND OTHER ADDITIONAL REPAIRS OF DA-BFAR MCS 3009 PATROL VESSEL** awarded to **JOSEFA SLIPWAYS INC.** in the amount of **FOURTEEN MILLION EIGHT HUNDRED NINETY-ONE THOUSAND THREE HUNDRED FORTY-FOUR AND 85/100 PESOS ONLY (Php 14,891,344.85)** for being the bidder who offered the **Single Calculated Responsive Bid**.

**RESOLVED FINALLY** that the Notice of Award be issued to the above-stated bidder, for the preparation of the contract agreement, Notice to Proceed, and commencement of the delivery of the Goods.
