**CONTRACT AGREEMENT**

THIS AGREEMENT made the 21 day of MAR 2024 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **JOSEFA SLIPWAYS INC.** 1326 M. Naval St., San Roque Navotas City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for **BID REFERENCE NO. "2024-04 GENERAL OVERHAULING OF PORT MAIN ENGINE AND OTHER ADDITIONAL REPAIRS OF DA-BFAR MCS 3009 PATROL VESSEL"** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FOURTEEN MILLION EIGHT HUNDRED NINETY-ONE THOUSAND THREE HUNDRED FORTY-FOUR AND 85/100 PESOS ONLY (Php 14,891,344.85)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and


