



CONTRACT AGREEMENT FOR THE PROCUREMENT OF GOODS & SERVICES

CONTRACT AGREEMENT

THIS AGREEMENT made the 04 day of April 2024 between **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** of the Philippines (hereinafter called "the Entity") of the one part and **INCA PHILIPPINES, INC.** of *Building 4, Philcrest Compound, Km. 23, West Service Road, Bo. Cupang, Muntinlupa City* (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, for **BID REFERENCE NO. 2024-18** entitled "**SUPPLY, DELIVERY, AND INSTALLATION OF FOUR (4) UNITS 20M DIAMETER SINGLE PIPE HDPE OFFSHORE SEAWEED CAGE AT DENRICA, GARTCHITORENA, CAMARINES SUR**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Seven Million Two Hundred Seventy-Six Thousand Eight Hundred Eighty pesos only (PhP7,276,880.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

In consideration for the sum of **Seven Million Two Hundred Seventy-Six Thousand Eight Hundred Eighty pesos only (Php7,276,880.00)** or such other sums as may be ascertained, **INCA PHILIPPINES, INC.** agrees to **BID REFERENCE NO. 2024-18** entitled "**SUPPLY, DELIVERY, AND INSTALLATION OF FOUR (4) UNITS 20M DIAMETER SINGLE PIPE HDPE OFFSHORE SEAWEED CAGE AT DENRICA, GARTCHITORENA, CAMARINES SUR**" in accordance with his/her/its Bid.
4. The **BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
