## "SUPPLY AND DELIVERY OF ORIGINAL MAINTENANCE PARTS OF CAT 3412E MARINE ENGINE, CAT 3054 NA & CAT C4.4 MARINE GENSET OF 10 UNITS DA-BFAR MCS PATROL VESSEL"

The Department of Agriculture - Bureau of Fisheries and Aquatic Resources (DA-BFAR), through the General Appropriations Act for 2024 intends to apply the sums of EIGHT MILLION NINE HUNDRED THOUSAND SEVEN HUNDRED TWENTY PESOS ONLY (Php 8,900,720.00) being the ABC to payments under the contract for Bid Reference No. 2024-19 entitled "Supply and Delivery of Original Maintenance Parts of CAT 3412E Marine Engine, CAT 3054 NA & CAT C4.4 Marine Genset of 10 DA-BFAR Vessel".

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 1. The DA BFAR, now invites bids for the above Procurement Project. Delivery of the Goods is required within the period stated in the Section VI Schedule of Requirements. Bidders should have completed, within **TWO (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - **a.** Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding

capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 3. Prospective Bidders may obtain further information from DA BFAR BAC Secretariat and inspect of the Bidding Documents at the address given below during office hours from 8:00 AM to 5:00 PM, Monday to Friday or download the at www.bfar.da.gov.ph.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders at the 2<sup>nd</sup> Floor, BAC Office, Fisheries Building Complex, BPI Compound, Brgy.
